S2102	142-2800	Division of the Arts-Decentralized Arts FY21-22	Grant award received for the Parish to serve as a regional development agency by developing and implementing a regional arts grants process for St. Tammany Parish and St. Bernard Parish, including funds to regrant to local organizations.
L2001	144-3000	Florida Parishes Juvenile Justice Commission-CCF	Grant award received to emphasize meaningful work experience to assist St. Tammany Parish youth in acquiring improved positive skills toward learning, career exploration, life skills, and character development.
F1805	200-4640	DOTD-Safe Routes to Public Places	Grant award previously budgeted for engineering and construction of a sidewalk from Coquille to White Chapel Rd. was awarded to DOTD who is managing the project.
F2013	202-4001	EPA-Lake Ponchartrain Basin Restoration Program	Grant award received to complete a review and amend existing construction development ordinances to remove low impact development impediments, and create low impact development guidelines for infrastructure improvements. The purpose of the program is to reduce water quality degradation and flooding potential caused by increased stormwater runoff rates associated with new development. Total project funding is \$45,000 as follows: \$30,500 from EPA, and \$14,500 from Capital Projects fund 202-4001 - Environmental Services - Planning.
