



COMPREHENSIVE PLAN:

Commercial - Sales outlets for goods and services. Several levels or forms of commercial structures include: limited or specialty; neighborhood service centers; generous "highway commercial" uses; offices; public uses; planned mixed commercial and residential centers, and the traditional village or town central business district.

STAFF COMMENTS:

The petitioner is requesting to change the zoning classification from HC-2 Highway Commercial District to HC-3 Highway Commercial District. The site is located on the north side of U.S. Highway 190, west of Sunset Drive, Slidell. The 2025 Future Land Use Plan designations the site to be developed with several forms of commercial structures.

The purpose of the existing HC-2 Highway Commercial District is to provide for the location of moderately scaled retail uses versus the purpose of the HC-3 Highway Commercial District which is to provide for the location of largescale, heavy commercial retail, office and service uses. The requested zoning change to HC-3 will create an increase in the intensity of the allowable uses in the area.

Note that the reason for the request is to accommodate a wedding venue.
