AN ORDINANCE TO CORRECT THE ST. TAMMANY PARISH SELECTIVE MAINTENANCE ROAD MAINTENANCE SYSTEM INVENTORY BY ADDING APPROXIMATELY 382 FEET TO THE LENGTH OF BLANCO DR. NORTH OF ORCHARD ST. FOR A TOTAL OF 1,942 FEET (R09J053) WARD 9, DISTRICT 12)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require update/amending periodically for corrections/additions, deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by the area Foreman, Act of Exchange and/or Act of Donation.

WHEREAS, it has been discovered that approximately 382 feet was inadvertently omitted from the road inventory report.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System be amended as follows:

add 382 feet to existing 1,560 feet, for a total of 1,942 feet on Blanco Dr. north of Orchard St.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
