**Funding Source: Ad Valorem Tax, Available Fund Balances, and FEMA Grant Funds**

Lakefront Pump Station

Allocate available funds to replace or repair and elevate two pumps, and raise electrical controls above BFE. Total project funding is \$731,620.00 as follows: \$187,022.47 from Capital Projects fund 201-4606 - Drainage - Parishwide, \$32,480.00 from Special Revenue fund 100-4601 - Public Works, \$111,015.47 from VDA funds, \$20,000.00 from Capital Projects fund 200-4653 - Sales Tax District 3 - District 13, \$341,102.06 from FEMA, and \$40,000.00 from Drainage District No.2.
