Mandeville Lakefront Wetlands Restoration

Allocate available funds to participate in an agreement with the City of Mandeville for the construction of a 1,200 linear foot armored earthen flood protection berm between Lakeshore Dr. and Sunset Point Park to provide shoreline protection, restore functional wetlands hydrology, and provide water quality benefits associated with routing Galvez Outfall stormwater through the restored wetlands. The total cost of the project is projected to be \$3,988,167 with STPG providing \$1 million for construction.
