ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE A CERTAIN PARCEL AND/OR SERVITUDE CONSISTING OF HONEYSUCKLE ROAD IN BUSH (WARD 5, DISTRICT 6)

WHEREAS, St. Tammany Parish Government desires to acquire servitude rights in and to Honeysuckle Road in Bush, La, consisting of a sixty fee (60’) wide right-of-way having a length of one thousand seven hundred twenty feet (1,720’) (the "Property"); and

WHEREAS, there is a need and public purpose for the acquisition of the Property for the benefit of road improvements, which will serve to improve traffic conditions; and

WHEREAS, Parish desires to acquire the Property and authorizes the Office of the Parish President to do whatever is necessary to enter into negotiations and acquire said Property.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Parish of St. Tammany, though the Office of the Parish President, is authorized to acquire by purchase, donation or otherwise, a servitude for sixty feet (60’) by one thousand seven hundred twenty feet (1,720’) right of way known as Honeysuckle Road in Bush, La (the "Property"); and

BE IT FURTHER ORDAINED: that pursuant to all applicable provisions of law, the Office of the Parish President is authorized to do whatever is necessary to acquire said Property; and

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to exercise its discretion in acquiring the Property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that, if purchased, the purchase price shall not exceed the fair market value of the Property as evidenced by and appraisal, plus closing fees and costs; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
