A RESOLUTION URGING THE LOUISIANA COASTAL PROTECTION AND RESTORATION AUTHORITY TO MITIGATE, TO THE FULLEST EXTENT POSSIBLE, THE IMPACTS OF CONSTRUCTING AND OPERATING THE MID-BARATARIA SEDIMENT DIVERSION.

WHEREAS, the St. Tammany Parish Council recognizes the value and urgent need of coastal protection restoration in Louisiana; and WHEREAS, the north shore of Lake Pontchartrain and the Pontchartrain Basin, similar to almost all basins in Louisiana, experiences land loss, erosion, and sea level rise; and WHEREAS, the Louisiana Coastal Protection and Restoration Authority (CPRA) is the single state entity responsible for planning the protection and restoration efforts of Louisiana’s coast for its citizens; and WHEREAS, the CPRA’s Coastal Master Plan for a Sustainable Coast (Coastal Master Plan) is the blueprint for implementing projects to protect and restore our coast; and WHEREAS, the Coastal Master Plan prioritizes two mid-basin sediment diversions to restore the natural functions of the Mississippi River’s land building capability, in addition to restoring the respective Basins’ estuaries which have been in decline since the Mississippi River was leveed; and WHEREAS, the Draft Environmental Impact Statement for the first mid-basin sediment diversion, the Mid-Barataria Sediment Diversion, was released on March 5, 2021 and identifies the benefits and impacts of the project on the Barataria Basin in Plaquemines and Jefferson parishes; and WHEREAS, the Mid-Barataria Sediment Diversion project was found to have both positive and negative impacts to the residents, fish and wildlife of the Barataria basin; and WHEREAS, the St. Tammany Parish Council recognizes the importance of coastal restoration for the state of Louisiana and the urgent need to implement restoration projects that will protect our coast and citizens from natural disasters and sea level rise, while sustaining our coast and habitats into the future; and WHEREAS, the St. Tammany Parish Council requests CPRA remain engaged and committed to working with the leaders, residents and industries most impacted by the Mid-Barataria Sediment Diversion; and WHEREAS, the St. Tammany Parish Council also requests CPRA remain engaged and committed to working with the leaders, residents and industries of St. Tammany Parish on protection and restoration issues in the Pontchartrain Basin.

THEREFORE, BE IT RESOLVED, the St. Tammany Parish Council urges and requests the Louisiana Coastal Protection and Restoration Authority to define and implement mitigation measures that minimize negative impacts and maximize the positive impacts to the Barataria Basin, its residents and businesses for the Mid-Barataria Sediment Diversion project; and to continue its protection and restoration efforts in the Pontchartrain Basin. THEREFORE, BE IT FURTHER RESOLVED, adoption of this resolution represents a change in the position of the St. Tammany Parish Council from that expressed in Resolution C.S. No. C-6458 as passed at the May 6, 2021 meeting of the St. Tammany Parish Council as Off-The-Floor Item No. 3.
