East Slidell Water Consolidation, Ph.1

Grant award received for the East Slidell Water Consolidation Phase 1 project. The total project budget is \$22,799,471.15, with \$15,731,635.09 being funded by the Water Sector Program and \$7,067,836.06 being funded as the 31% match from the Parish's ARPA funds. The project will add a new water well, 2 water towers that will provide storage capacity and fire protection, 2 permanently mounted generators that will provide resiliency during adverse weather events, and SCADA technology that will allow remote monitoring of the system. The project will consolidate 5 water systems, providing secondary water sources for 4 of the 5 systems being consolidated and bringing them into compliance with LDH regulations. All of these improvements add to the system redundancy and resiliency.
