AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE TRACE LOOP LATERAL (D04DW02061), FROST LANE LATERAL (D04DW01108), COLONY TRAIL LATERAL (D04DW01077), COLONY TRAIL LATERAL (D04DW02077), COLONY TRAIL LATERAL (D04DW03077), CANAAN PLACE LATERAL (D04DW01074), LONESOME RD. LATERAL (D04DW05032), GREENLEAVES BLVD. (D04DW02060) (WARD 4, DISTRICT 10)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically for corrections/additions, deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman, Act of Exchange and/or donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System is amended as follows:

1. Add Trace Loop Lateral (D04DW02061), runs S off of Greenleaves Trace Loop for 142 ft., between 120 & 106 Trace Loop
2. Add Frost Lane lateral (D04DW01108), runs W off of Frost Lane for 165 ft., between 202 & 201
3. Add Colony Trail lateral (D04DW01077) runs NW off Colony Trail for 225 ft., between 11 & 10 - ends at pond
4. Add Colony Trail lateral (D04DW02077) runs NW off Colony Trail for 170 ft., on lot 15 - ends at pond
5. Add Colony Trail lateral (D04DW03077) runs NW off Colony Trail for 160 ft., between 18 & 17 - ends at pond
6. Add Canaan Place lateral (D04DW01074) runs NW off Canaan Place for 160 ft., between 330 & 326 - ends at Lonesome Rd.
7. Add Lonesome Rd. lateral (D04DW05032) runs S off Lonesome Rd. for 590 ft., on backside of lots 9-14 in Canaan Place subdivision
8. Add Greenleaves Blvd, lateral (D04DW02060) runs N off Greenleaves Blvd. for 1360 ft., on back side of lots 16-29 - ends at Lonesome Rd.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
