| Fritchie Marsh-Salt Bayou           | Allocate an additional \$200,000 of GOMESA funding for marsh creation in an area identified as critical in the Coastal Protection and Restoration Authority (CPRA) Coastal Master Plan. This project will identify the optimal marsh site within Fritchie Marsh near Salt Bayou, identify a suitable borrow source from Lake Pontchartrain, and then develop a full engineering, design, and permitting package suitable for project construction. The previous \$400,000 CPRA funds have lapsed. |
| Lock No.1 Boat Launch Restoration   | Allocate additional funds for the restoration of the boat ramp area at the Pearl River Diversion Canal Lock No.1. Project will include boat ramps and roads, and will provide coastal protection, conservation, hurricane protection, and infrastructure which were directly affected by coastal wetland losses.  |
| Slidell Pier Breakwater Restoration | Reduce funds for the restoration of the shoreline breakwater and associated improvements as the site was heavily damaged during Hurricane Ida.  |
