Slidell Ring Levees Analyses	Allocate additional funds to conduct an evaluation of the Oak Harbor and Kingspoint ring levee systems. This analysis will utilize Levee Analysis and Mapping Procedures (LAMP) to ensure both levee systems provide protection and meet the structural 100-year flooding event requirements as defined by FEMA. Anticipated deliverables include a comprehensive LAMP report, updated flood maps, and Base Flood Elevation (BFE) regulations.
