**CAPITAL FUND 249 - CAPITAL-GRANTS- OTHER**      **Funding Source: Dept of Treasury, ARPA funds**

This is to reserve some of the funds from the first allocation of ARPA funds of \$25,291,669.00. All projects must be qualified for funding use in accordance with all requirements of the American Rescue Plan Act of 2021. Funds may be used directly or as match to accomplish these projects. As specific projects are identified, they will be submitted individually for introduction and adoption.

Broadband Infrastructure Projects	Allocate funds to serve as Parish match for the application to the State for broadband infrastructure needs in areas of St. Tammany Parish that do not currently have fiber. The Parish is submitting an application under the State's GUMBO grant program of approximately \$25 million with a 20% required match. The project will increase the affordability of broadband services and enhance digital literacy in St. Tammany.
