ORDINANCE TO AMEND ST. TAMMANY PARISH CODE OF ORDINANCES ARTICLE XVII PARISH FEES, DIVISION 8 MANAGEMENT INFORMATION SERVICES, SECTION 2-658 ADMINISTRATIVE DOCUMENTS AND SECTION 2-932 FEES FOR GIS DATA/MAPS TO REMOVE REFERENCES TO FLOPPY DISKS.

WHEREAS, floppy disks are no longer used by St. Tammany Parish Government and references to productions on floppy disks should be removed.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that Section 2-932 be amended as follows to remove references to floppy disks.

**Amend Section 2-658 (6)(c) to remove the following:**

**Amend Section 2-658(6)(d) to remove the following:**

~~Map on floppy disk...\$ 10.00~~

**Amend Section 2-932(a) to remove the following:**
