ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO GRANT ONE OR MORE SERVITUDES ACROSS A 0.714 ACRE PARCEL ADJOINING OLD MILITARY ROAD IN PEARL RIVER (WARD 8, DISTRICT 9)

WHEREAS, St. Tammany Parish Government owns the 0.714 acre parcel shown on the survey attached hereto (the "Property"); and

WHEREAS, the Property was acquired for economic development purposes to serve as additional right of way along Old Military Road within the corporate limits of Pearl River; and

WHEREAS, it is the desire of St. Tammany Parish Government to grant one or more access servitudes across the Property in favor of adjoining landowners, their successors and assigns; and

WHEREAS, there is a need and a public purpose for the granting of servitudes to provide for public access to Old Military Road through the Property.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government, through the Office of the Parish President, is authorized to enter into one or more servitude agreements for the 0.714 acre property depicted on the survey attached hereto (the "Property") for the purposes of providing access to Old Military Road; and

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized to exercise its discretion in granting one or more servitudes on the Property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that all actions previously taken by the Office of the Parish President to grant one or more servitudes on the Property are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective immediately upon adoption and execution.

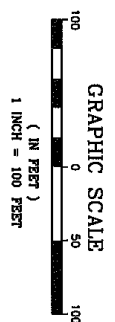

The Property was originally acquired for economic development purposes related to Project Icebox.

 From the Point of Beginning and leaving the westerly right of way line of Old Military Road run South 67 Degrees 36 Minutes 41 Seconds West a distance of 40.08 feet to a point; Thence run North 25 Degrees 59 Minutes 29 Seconds West a distance of 126.54 feet to a point; Thence run North 34 Degrees 07 Minutes 57 Seconds West a distance of 83.55 feet to a point; Thence run North 47 Degrees 00 Minutes 42 Seconds West a distance of 471.49 feet to a point; Thence run North 89 Degrees 57 Minutes 40 Seconds West a distance of 58.61 ft. to a 3/4" iron rod found on the westerly right of way line of Old Military Road; Thence a distance said westerly right of way line of Old Military Road the following calls - South 47 Degrees 00 Minutes 10 Seconds East a distance of 431.00 feet to a point; Thence run South 40 Degrees 15 Minutes 59 Seconds East a distance of 101.65 feet to a point; Thence run South 34 Degrees 07 Minutes 59 Seconds East a distance of 88.55 feet to a point; Thence run South 25 Degrees 58 Minutes 29 Seconds East a distance of 143.89 feet and back to the Point of Beginning.
