Grant award received to acquire six 16-passenger and four 12-passenger transportation vehicles to be used by Council on Aging St. Tammany (COAST). Total funding for the vehicles includes \$682,868.34 from FTA (85%) and \$120,506.18 from Parish Funds (15%).
