WHEREAS, the Parish Council, acting as governing authority, has determined that it is in the Parish's best interest to engage Bond Counsel to assist parish government in matters of tax elections, structuring and issuance of bonds, and other public financing concerns; and

WHEREAS, a Bond Counsel Request for Proposals (RFP) was prepared and advertised in the Official Journal, on the Parish Website and by directly soliciting firms known to be interested in providing the services. The Parish evaluated the responses received according to the stated selection criteria, and selected *Foley & Judell, L.L.P.* as the firm most advantageous to the Parish with price and all other stated criteria considered.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES, through its Parish Council acting as governing authority and with the purposes, reasons and requirements herein above stated, to engage Foley & Judell, L.L.P. as Bond Counsel to the Parish of St. Tammany in public financing and related matters requiring approval by the State Bond Commission.

BE IT FURTHER RESOLVED that Parish President Michael B. Cooper be authorized to engage the selected firm, Foley & Judell, L.L.P. according to the terms specified and negotiated in the Request for Proposal.
