ORDINANCE ESTABLISHING INCREASED MILLAGE RATES FOR THE YEAR 2022.

WHEREAS, the Home Rule Charter for St. Tammany Parish Section 2-11 (3) requires an ordinance to levy taxes, assessments and charges.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that in a public meeting held on July 7, 2022, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the Parish Council voted to increase the millage rates, but not in excess of the prior year’s maximum rates, on all taxable property shown on the official assessment roll for the year 2022, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied. Said millage rates are:
