**ORDINANCE ESTABLISHING PARCEL FEES FOR THE YEAR 2022.**

WHEREAS, the Home Rule Charter for St. Tammany Parish Section 2-11 (3) requires an ordinance to levy taxes, assessments and charges.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that in a public meeting held on July 7, 2022, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the following **parcel fees** be and they are hereby levied upon the dollar of the assessed valuation of all property subject to this fee within said Parish for the year 2022, for the purpose of raising revenue:

THE PARISH OF ST. TAMMANY HEREBY FURTHER ORDAINS that the Assessor of the Parish of ST. TAMMANY, shall extend upon the assessment roll for the year 2022 the taxes herein levied, and the tax collector of said Parish shall collect and remit the same to said taxing authority in accordance with law.
