**CAPITAL FUND 201 - DRAINAGE -  
PARISHWIDE**

**Funding Source: Ad Valorem Tax and Available Fund Balance**

Fonchie Memorial Property

Allocate available funds to acquire property for the purpose of maintaining parishwide drainage. Site may be utilized for the storage of materials including debris, dirt, mud, and vegetation removed from Parish right-of-ways and waterways. Site may also be utilized for the storage of equipment and to facilitate Parishwide drainage projects.

Waterway Debris Removal & Monitoring

Allocate available funds for waterway debris removal due to Hurricane Ida. Total project budget of \$12,638,018.50 is as follows: \$2,579,187.50 from Drainage Maintenance Capital Project Fund 201-4600 and \$10,058,831.00 from USDA-NRCS Grant funds.
