# ADMINISTRATIVE COMMENT AMENDMENT NO. 26 - 2022 CAPITAL IMPROVEMENTS - APRIL 2022

CAPITAL FUND 200-4670 - SALES TAX DISTRICT 3 - TAMMANY TRACE

Funding Source: 2% Sales Tax and Available Fund Balance

Trace Connection to Heritage Park

Allocate additional funds to extend the Tammany Trace connection approximately three miles along the Parish owned railroad ROW from Gause Blvd. to Heritage Park. Bridges along the ROW will be traversed, requiring repairs and/or replacement. The City of Slidell will contribute \$556,936.98, approximately 30% of the projected project cost.
