RESOLUTION TO AMEND THE MAJOR ROADWAY SYSTEM LIST DEVELOPED AS PART OF THE TRANSPORTATION IMPACT FEE STUDY TO AMEND CERTAIN ROADS AS PART OF THE MAJOR ROADWAY SYSTEM

WHEREAS, St. Tammany Parish Government has established Road Impact Fees to address the need for additional road capacity to alleviate traffic generated by new development; and

WHEREAS, funds generated by the Road Impact Fees are designated to capacity-related improvements to the roads identified on the Major Road System list reflected in the applicable Road Impact Fee Study; and

WHEREAS, an ongoing review of the Major Road Plan for St. Tammany Parish has determined that certain roads either function as major roads or will do so in the future.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that it is beneficial and necessary to include these roads in the Major Road System to alleviate traffic generated by new development, and hereby added these certain roads to the Major Roadway System of St. Tammany Parish as shown in the attached.

- US 11 - All roadway within the limits of unincorporated St. Tammany Parish
- US 190B - All roadway within the limits of unincorporated St. Tammany Parish
- US 90 - All roadway within the limits of unincorporated St. Tammany Parish
