AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE RAEHYO LANE LATERAL; 2 GOTTSCHALK ROAD LATERALS; BLUE CRANE NO. 1 LATERAL; AN EXTENSION OF MCDONALD ROAD LATERAL; AND AN EXTENSION OF HIGHWAY 190 LATERAL. (WARDS 1, 3, & 8) (DISTRICTS 3 & 9)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

- 1. Add Raehyo Lane Lateral (D03EW01013), approximately 1,000 feet, located east then south from the backside of the Raehyo Lane (R03E013) cul de sac, Ward 3, District 3; and
- 2. Add Gottschalk Road Lateral (D01AW02002), approximately 760 feet, located west from Gottschalk Road (R01A002), Ward 1, District 3; and
- 3. Add Gottschalk Road Lateral (D01AW03002), approximately 420 feet, located northwest from Gottschalk Road (R01A002), Ward 1, District 3; and
- 4. Add Blue Crane No. 1 Lateral (D8NW05040), approximately 295 feet, located east from Blue Crane No. 1 (R08N040), Ward 8, District 9; and
- 5. Add an extension to McDonald Road Lateral (D01GW02006), approximately 4,000 feet, Ward 1, District 3; and
- 6. Add an extension to Highway 190 Lateral (D01HW01190), approximately 10,900 feet, Ward 1, District 3.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
