WHEREAS, the Maritime Pilots’ Institute, Inc., a Louisiana non-profit corporation (“MPI”), is seeking to establish a training facility for maritime pilots and for those who would likewise seek training with manned training models, and

WHEREAS, Parish has received grant funding to develop and implement the maritime training institute; and

WHEREAS, the Parish owns materials, moveable property and equipment suitable for MPI’s use for training of maritime pilots.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish President is hereby authorized to sign and/or execute a Cooperative Endeavor Agreement between St. Tammany Parish and Maritime Pilots’ Institute, Inc. regarding the objectives stated above.
