Warranty Obligation (\$49, 500)

Honorable Council Members:

The extended Warranty Obligation in the amount of \$49,500 expires May 5, 2017 and is scheduled for review by the Parish Council at the April 6, 2017meeting.

The developer was notified on January 11, 2017 by the Department of Engineering of the punch list items required and for his engineer to certify to this office at least sixty (60) days prior to the expiration of the obligation, that the punch list has been completed. If not, the obligation will be automatically called.

This office has not received such notification. Therefore, this obligation would normally be called. However, in accordance with Resolution Council Series No. C-1528, passed at the September 28, 2005 Special Parish Council meeting regarding Hurricane Katrina, the Warranty Obligation will be extended for (1) year from the expiration date shown or until the work has been satisfactorily accomplished.

The following punch list items were submitted to the developer on January 11, 2017 and remain:

- 1. Detention pond banks and slopes do not have a mature stand of grass in several locations which is allowing "rain wash gullies" to develop. All banks and slopes must have a mature stand of grass before the warranty obligation can be released.
- 2. Roadside ditches have standing water in many locations. Silt in the ditches is the cause of standing water.
- 3. Home builders in many locations are not maintaining the access to the site in a manner to prevent silt from entering the roadside ditches, causing upstream overbank flooding conditions.
- 4. Adequate BMP's are needed at the lots to prevent silt from entering the roadside ditches.
- 5. Out fall ditches between the pond and Tantella Ranch Rd. ditch need to be regraded to remove extensive silt build up.
- 6. Replace blue reflectors where needed.

The above referenced Performance Obligation expires May 3, 2017 and is scheduled for review by the Parish Council at the April 6, 2017meeting. The work covered by this obligation has not been accomplished.

The following punch list items remain:

- 1. AS-BUILT drawing needs to be revised to show that signage is in place; this includes speed limit signs;
- 2. The roadside ditches do not have positive flow and do not exit into the cross culvert at River Highland Blvd. Regrade roadside ditches. A mature stand of grass is needed before the Performance Obligation can be released.
- 3. The dumpster pad and dumpster facility needs to be removed from Parish R.O.W

This office has not received notification from the developer's engineer that the punch times have been accomplished.

Therefore, this obligation must be extended for six (6) months or until the work is satisfactorily accomplished.

Honorable Council Members:

The above referenced Performance Obligation in the amount of \$14,400 expires May 3, 2017 and is scheduled for review by the Parish Council at the April 6, 2017meeting.

The following punch list items remain:

- 1. Roadside ditches are silted up and need to be regraded to provide positive flow;
- 2. Out fall ditches are silted up and need to be regraded to provide positive flow;
- 3. Swales between lots still are not functioning and must be constructed in accordance with sheet F-1; dated 9/6/06 prepared by Cooper Engineering, Inc.
- 4. Silt abatement measures are not functioning. Best Management Practices need to be employed to prevent siltation. It will be necessary that your engineer furnish a silt abatement plan for review by our Watershed Coordinator.
- 5. The signs need to be installed along with blue reflectors all in accordance with latest signage specifications.
- 6. As-Built drawings are needed upon completion of the regrading of all ditches, swales and signage;
- 7. The ASPHALT roadway linear cracks need to be cleaned out and approved crack filler material needs to be applied.
- 8. Roadway shoulders need to be constructed in accordance with the approved drawings.
- 9. Clean our all cross culverts.

This office has not received notification from the developer's engineer that the punch times have been accomplished.

Therefore, this obligation must be extended for six (6) months or until the work is satisfactorily accomplished.
