RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE CITY OF SLIDELL FOR RESURFACING OF BROWNSWITCH ROAD (WARD 8, DISTRICTS 8 AND 9).

WHEREAS, the road known as Brownswitch Road consists of one continuous road partially inside of and outside of the corporate limits of the City of Slidell; and

WHEREAS, Brownswitch Road is in need of repaving; and

WHEREAS, Parish and Slidell desire to enter into a Cooperative Endeavor Agreement to coordinate construction and save costs by utilizing a single contractor to repave Brownswitch Road; and

WHEREAS, Parish will procure a contractor and Slidell shall provide payment to Parish for a share of the cost of the work.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09, is authorized to execute a Cooperative Endeavor Agreement with the City of Slidell, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the repaving of Brownswitch Road and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

BE IT FURTHER RESOLVED, that all acts previously taken by the Office of the Parish President in furtherance of the agreement contemplated herein are hereby ratified and approved.

Brownswitch Road forms one continuous road, which is partially within the corporate limits of the City of Slidell. Combining the repaving work into one project will reduce separate mobilization costs otherwise payable by Parish and City in separate repaving projects. Costs will be shared between the parties.
