TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE CITY OF COVINGTON FOR RESURFACING OF EAST 32ND AVENUE (WARD 3, DISTRICT 3).

WHEREAS, East 32nd Avenue, located in the City of Covington, is in need of surface repair and/or replacement; and

WHEREAS, although located within the city limits of Covington, East 32nd Avenue is also traversed by traffic originating from the unincorporated areas along Collins Boulevard and Lee Road; and

WHEREAS, Parish has agreed to enter into a Cooperative Endeavor Agreement with the City of Covington to cooperate and fund, in part, the replacement and/or repair of East 32nd Avenue between Collins Boulevard and Lee Road.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09, is authorized to execute a Cooperative Endeavor Agreement with the City of Covington, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the repaving of East 32nd Avenue and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

BE IT FURTHER RESOLVED, that all acts previously taken by the Office of the Parish President in furtherance of the agreement contemplated herein are hereby ratified and approved.
