ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO AMEND AN EXISTING CONSERVATION SERVITUDE WITH WBB REALTY, LLC TO ACQUIRE ADDITIONAL PROPERTY AND RELEASE CERTAIN PROPERTY FROM MAISON DU LAC CONSERVATION AREA (WARD 1, DISTRICT 1).

WHEREAS, St. Tammany Parish and New Town Concepts, LLC are parties to that certain Conservation Servitude dated August 17, 2005 and recorded August 18, 2005 at Conveyance Instrument No. 1513036 pertaining to greenspace, wetlands and buffer property within Maison du Lac Subdivision (formerly known as Beau L'Age Subdivision); and

WHEREAS, WBB Realty, LLC acquired all interests in the subdivision from New Town Concepts, LLC and desires to amend the conservation servitude to include certain property (0.962 acres) as well as release certain property (0.39 acres) from the conversation servitude, all as authorized by the original Conservation Servitude.

WHEREAS, the amendment will allow WBB Realty, LLC to proceed with an additional Phase 3 to Maison du Lac Subdivision.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to authorize the Parish of St. Tammany to acquire 0.962 acres and release 0.39 acres by amendment to conservation servitude, in the locations depicted as attached hereto; and

BE IT FURTHER ORDAINED: that pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to do whatever is necessary to acquire and/or release the parcels referenced herein from WBB Realty, LLC;

BE IT FURTHER ORDAINED: that the Office of the Parish President is authorized and instructed to proceed with an amendment to the conservation servitude, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
