RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09 FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH ST. TAMMANY PARISH DRAINAGE DISTRICT NO. 4 FOR DRAINAGE IMPROVEMENTS (WARD 8, DISTRICT 14).

WHEREAS, the drainage feature commonly known as the Shylock Canal is located within the area comprising the jurisdiction of Drainage District No. 4; and

WHEREAS, the parties desire that Parish provide cleaning and maintenance services to the Shylock Canal; and

WHEREAS, cleaning and maintenance of the Shylock Canal will improve the removal of storm water, which benefits citizens of St. Tammany Parish by reducing the risk of flooding.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter Sections 1-04, 1-06, 3-01 and 3-09, is authorized to execute a Cooperative Endeavor Agreement with St. Tammany Parish Drainage District No. 4, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the cleaning and maintenance of the Shylock Canal and to take any and all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.
