ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE BY DONATION LOT 69, SQUARE 10, PALM PLAZA SUBDIVISION (WARD 3, DISTRICT 2)

WHEREAS, St. Tammany Parish desires to acquire certain immovable property identified as Lot 69, Square 10, Palm Plaza Subdivision; and

WHEREAS, there is a need and a public purpose for the acquisition of said immovable property to provide for road maintenance, improvements and ownership; and

WHEREAS, St. Tammany Parish desires to acquire the immovable property and authorize the Office of the Parish President to do whatever is necessary to acquire said property.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government, through the Office of the Parish President, is directed and authorized to acquire by donation Lot 69, Square 10, Palm Plaza Subdivision ; and

BE IT FURTHER ORDAINED: that pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to do whatever is necessary to acquire said parcel; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
