### ORDINANCE ESTABLISHING A NO PARKING ON PAVEMENT ZONE ON PORTION OF MELISSA LANE (WARD 3, DISTRICT 2)




Figure 2A-3. Examples of Locations for Some Typical Signs at Intersections
