AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE A PORTION OF SAVANNAH ROAD; A PORTION OF SCHIRO ROAD; A PORTION OF STARLING DRIVE; FIFTH AVENUE; MILITARY ROAD LATERAL; THETA AVENUE LATERAL; 7TH STREET; AND A PORTION OF 4TH STREET. WARDS 1, 3, 4, 8 & 10, DISTRICTS 2, 3, 5, 6 & 9

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: , that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Include an extension of Savannah Road (R01G001), approximately 1,030 feet, located in Ward 1, District 3; and

2. Include an extension of Schiro Road (R03G004), approximately 640 feet, located in Ward 3, District 2; and

3. Include an extension of Starling Drive (R08N151), approximately 1,528 feet, from the south end to the cul-de-sac, Ward 8, District 9;

4. Include Fifth Avenue Lateral (#D10FW01006), approximately 450 feet, located south east off Fifth Avenue (R10F006), Ward 10, District 6; and

5. Include Military Road Lateral (#DHL1090W001), approximately 1,210 feet, located between Cypress Cove and Honey Island School on Military Road/Highway 1090, Ward 8, District 9; and

6. Include Theta Avenue Lateral (#D03IW01025), approximately 500 feet, located north off Theta Avenue (R03I025), Ward 3, District 2; and

7. Include 7th Street, approximately 350 feet, located northwest off Lasalle Street (R04D059) ending as Desoto Street (R04D173), Ward 4, District 5; and

8. Include an extension of 4th Street (R03L263), approximately 635 feet, located in Ward 3, District 2.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
