ORDINANCE AMENDING ORDINANCE C.S. 07-1600 ESTABLISHING A NO PARKING ZONE ON THE WEST SIDE OF ALLEN ROAD. WARD 8, DISTRICT 14.

WHEREAS, Ordinance C.S. 07-1600 established a "no parking" zone on a portion of the west side of Allen Road (R08V001); and

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens; and

WHEREAS, after reevaluation of previously posted no parking signs by the Department of Engineering they have recommended the realignment of existing signage.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: the Parish Department of Public Works is directed to remove all existing no parking signs and post the appropriate signs at these locations, in accordance with the provided Engineering data.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

The Department of Planning & Development recommends the installation of Signage to be installed in District 14.

As per MUTCD, when <u>signs with arrows</u> are used to indicate the restricted parking zones, the signs with the arrows should be set at an angle of not less than 30 degrees and not more than 45 degrees with the line of traffic flow in order to be visible to approaching traffic.


- 1. Install NO PARKING (Left Arrow) sign on Allen Rd. 100' south of Highway 190, with sign facing north.
- 2. Install NO PARKING sign on Allen Rd. 220' south of Highway 190, with sign facing north.
- 3. Install NO PARKING sign on Allen Rd. 300' south of Highway 190, with sign facing north.
- 4. Remove NO PARKING sign that is below SPEED LIMIT 25 sign on Allen Rd. 415' south of Highway 190, and straighten pole.
- 5. Install NO PARKING sign on Allen Rd. 435' south of Highway 190, with sign facing north.
- 6. Install NO PARKING sign on Allen Rd. 525' south of Highway 190, with sign facing north.
- 7. Install NO PARKING sign on Allen Rd. 620' south of Highway 190, with sign facing north.
- 8. Install NO PARKING sign on Allen Rd. 720' south of Highway 190, with sign facing north.



- 13. Install NO PARKING (Right Arrow) sign on Allen Rd. 1240' south of Highway 190, with sign facing north.


