ORDINANCE TO NAME THE MADISONVILLE BRANCH OF THE PUBLIC LIBRARY IN HONOR OF FORMER MAYOR PETER L. (PETE) GITZ.

WHEREAS, the Louisiana Legislative 2017 Regular Session, House Bill 14, Act No. 77 authorized the governing authority of St. Tammany Parish to name the Madisonville branch library in St. Tammany Parish in honor of Peter L. (Pete) Gitz; and

WHEREAS, the St. Tammany Parish Council authorizes the naming of the Madisonville branch library after former Madisonville Mayor, Peter L. (Pete) Gitz, in honor of his many years of public service.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to name the Madisonville branch library in honor of Peter L. (Pete) Gitz.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
