RESOLUTION TO ACCEPT OWNERSHIP OF PORTIONS OF STATE ROUTES LA 1084, LA 1077 AND LA 434 FROM THE STATE OF LOUISIANA, DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT, SUBJECT TO THE CONDITIONS OUTLINED HEREIN AND TO AUTHORIZE THE PARISH PRESIDENT TO EXECUTE DOCUMENTS NECESSARY TO TRANSFER SAME.

WHEREAS, the St. Tammany Parish Council is agreeable to conditionally accept ownership of whatever rights the State of Louisiana, Department of Transportation and Development ("DOTD") may own in and to the following described property and agrees to accept all future rights, obligations and liabilities, including, but not limited to, all future operations, maintenance and repairs associated therewith for its operation and maintenance as a Parish road:

I. State Route La 1084, in its entirety, beginning at its junction with State Route La 21 and proceeding east approximately 1.494 miles to its junction with State Route La 1083.

II. The portion of State Route La 1077, beginning at its junction with State Route La 1078 and proceeding easterly approximately 4.308 miles to its junction with State Route La 25.

III. The portion of State Route La 434, beginning at its junction with State Route US 190 and proceeding southwesterly approximately 1.575 miles to its terminus, at or near its junction with the local road known as Barringer Rd.

WHEREAS, Louisiana Revised Statute 48:191 limits DOTD from increasing the length of the State highway system and the future construction of State Route La 3241 will result in additional mileage to the State highway system; and

WHEREAS, the Parish of St. Tammany is agreeable to accept ownership of whatever rights the DOTD may own in and to the aforesaid portion of the State Routes as to offset the addition of State mileage associated with the future construction of State Route La 3241; and

WHEREAS, the Parish of St. Tammany is agreeable to accept ownership of whatever rights the DOTD may own in and to the aforesaid portion of the State Routes at the proper time and under the conditions specified herein below:

CONDITION I: Provide any necessary repairs, including an asphaltic concrete application, to State Route La 1084 to be transferred to the Parish of St Tammany.

CONDITION II: Provide minor erosion and embankment stabilization repairs at and/or near the culverts on the portion of State Route La 1077 to be transferred to the Parish of St. Tammany.

CONDITION III: Provide any necessary repairs, including an asphaltic concrete application, to the portion of state Route La 434 to be transferred to the Parish of St. Tammany.

WHEREAS, the Parish of St. Tammany shall have the opportunity to review and comment on any State project(s) pertinent to the requirements of Conditions I and III above.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany shall accept ownership of whatever rights the DOTD may own in and to the aforesaid portions of the State Routes described herein as a binding agreement between the DOTD and the Parish of ST. Tammany, provided the DOTD complies with the relevant condition(s) described herein; and

BE IT FURTHER RESOLVED, that the Parish of St. Tammany authorizes the Parish President to execute any and all documents necessary to effect the transfer of the aforesaid described property at the proper time; and

BE IT FURTHER RESOLVED, in addition to the mileage already accepted by the Parish of ST .Tammany, upon the acceptance of the aforesaid portion of the State Routes described herein, the Parish of St. Tammany will have met any and all currently anticipated obligations related to the acceptance of required mileage associated with the future construction of La 3241.
