RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09 FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT CONCERNING THE FEDERAL OFF-SYSTEM BRIDGE REHABILITATION AND REPLACEMENT PROGRAM.

WHEREAS, under provisions of Title 23, U.S.C. Section 144 "Highway Bridge Replacement and Rehabilitation Program", as amended, funds have been appropriated from the Highway Trust Fund to finance replacement and/or rehabilitation of bridges located of the State and Federal road system; and

WHEREAS, Parish has requested that DOTD allocate funds necessary to finance the off-system bridge replacement and/or rehabilitation projects defined the the Parish's approved priority list; and

WHEREAS, Federal funds have been appropriated to finance replacement and/or rehabilitation projects under the direct administration of DOTD; and

WHEREAS, DOTD is agreeable to implementation of the projects and desires to cooperate with Parish through an Intergovernmental Agreement.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish of St. Tammany, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09 is authorized to enter into an Intergovernmental Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Transportation and Development, for rehabilitation and/or replacement of off-system bridges in St. Tammany Parish and to take any and all actions necessary to enter into the Intergovernmental Agreement in furtherance of same.
