RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09, FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH FRIENDS OF CAMP SALMEN NATURE PARK, INC. FOR THE PROVISION OF WIRELESS INTERNET SERVICES AT CAMP SALMEN (WARD 9, DISTRICT 14)

WHEREAS, Parish is the owner of Camp Salmen Nature Park, consisting of approximately 130 acres and generally located at 35122 parish Parkway, Slidell, la 70460 ("Camp Salmen"); and

WHEREAS, Friends of Camp Salmen Nature Park, Inc. ("Friends") was organized to assist Camp Salmen, through fundraising, donations and/or grants, with improvements and additions to Camp Salmen; and

WHEREAS, Friends desires to install Wi-Fi internet access at Camp Salmen for usage by visitors to Camp Salmen.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 3-01 and 3-09, is authorize to execute a Cooperative Endeavor Agreement with Friends of Camp Salmen Nature Park, Inc. which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the installation, operation and maintenance of Wi-Fi internet access at Camp Salmen and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.
