RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09 FOR THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE REGIONAL PLANNING COMMISSION FOR THE EAST LACOMBE LAND USE/TRANSPORTATION STUDY (WARD 9, DISTRICTS 7, 11, 14)

WHEREAS, St. Tammany Parish Government and the Regional Planning Commission desire to develop a land use and transportation study for the East Lacombe area in St. Tammany Parish; and

WHEREAS, the State of Louisiana, Department of Transportation and Development has provided funding for the study, subject to a local match; and

WHEREAS, Parish desires to provide funding for the local match in order to facilitate the Regional Planning Commission’s procurement of the study.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09, is authorized to execute a Cooperative Endeavor Agreement with the Regional Planning Commission, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the land use and transportation study for the East Lacombe area and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

Parish seeks to enter into a Cooperative Endeavor Agreement with the Regional Planning Commission for a land use and transportation study for the East Lacombe area. The general boundaries are U.S. 190 to the south, Hwy 434 to the west, Hwy 36 to the north and Airport Road/Northshore Boulevard to the east. RPC will procure and administer a contract with a vendor. Parish will provide the local match for DOTD funds otherwise provided to RPC.
