ON THE 12 DAY OF JULY , 2018

AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE MERINO ROAD; EVERARD DRIVE LATERAL; AND 2 HENRY HUNT ROAD LATERALS. WARDS 2, 6 & 7, DISTRICTS 2, 6 & 7

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

- 1. Include Merino Road, approximately 350 feet, located north east off Berry Todd Road in Ward 7, District 7; and
- 2. Include Everard Drive Lateral, approximately 375 feet, located east of Everard Drive in Ward 6, district 6; and
- 3. Include Henry Hunt Road Lateral, approximately 250 feet, located southwest off Henry Hunt Road in Ward 2, District 2; and
- 4. Include Henry Hunt Road Lateral, approximately 270 feet, located northwest off new Henry Hunt Lateral (above) in Ward 2, District 2.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

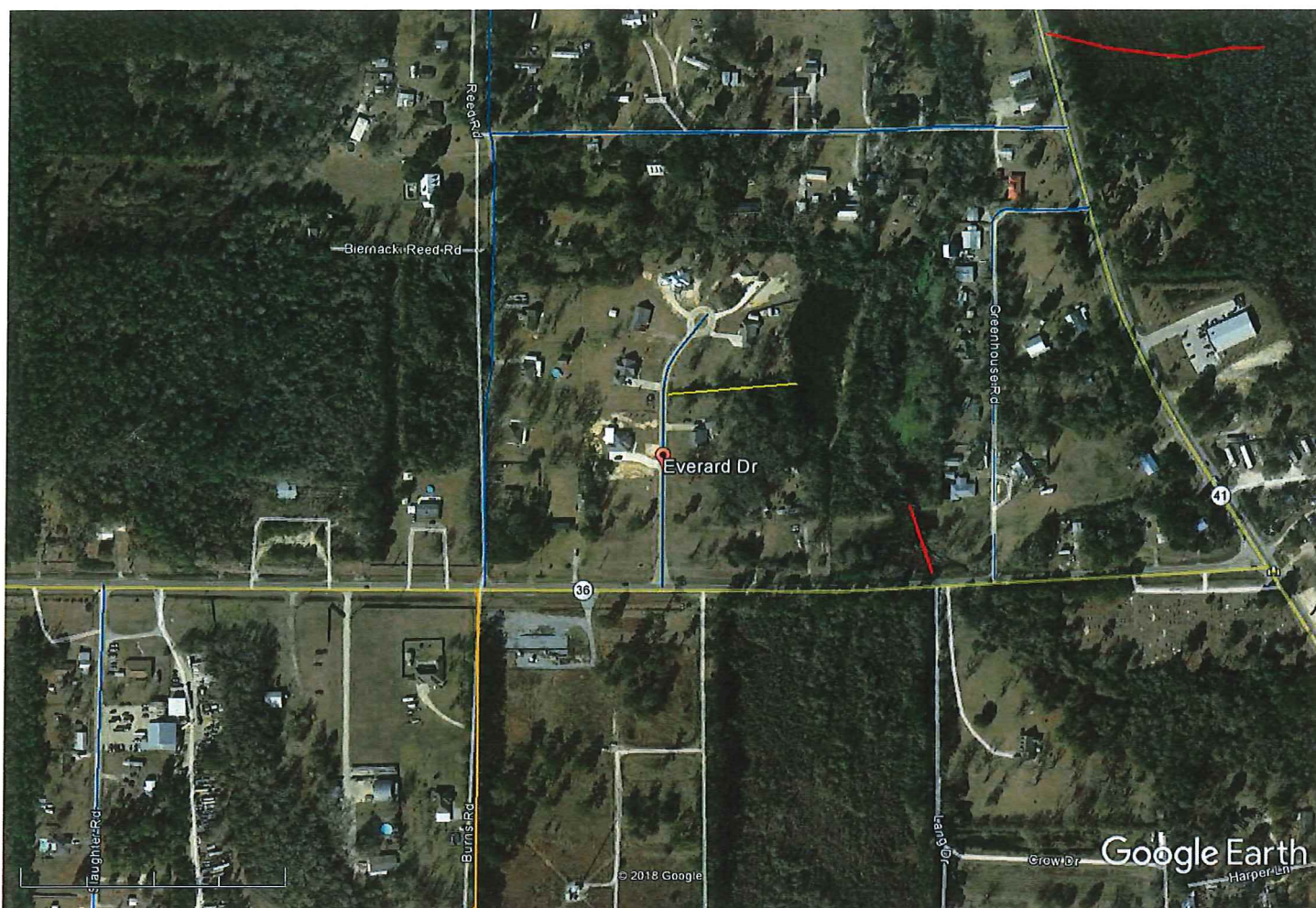


SB - SPOIL BANK (PLACE EITHER ON LD OR RD)

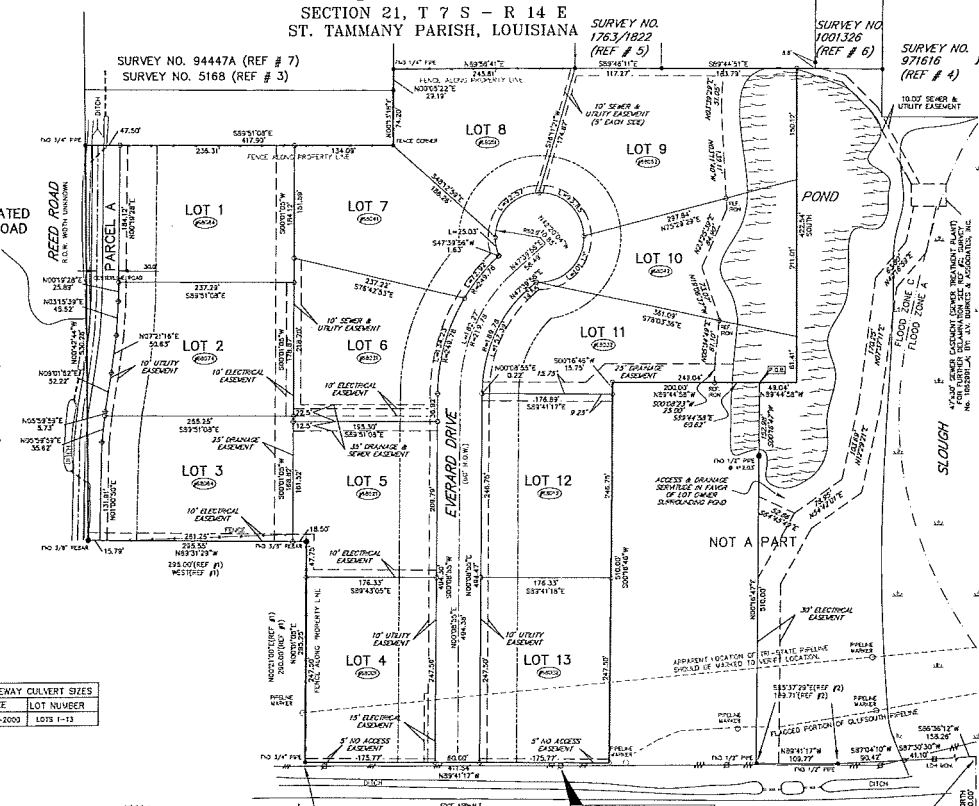
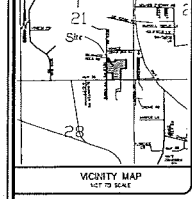

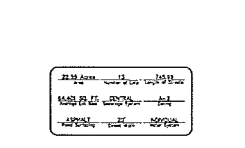

ST. TAMMANY PARISH, LOUISIANA



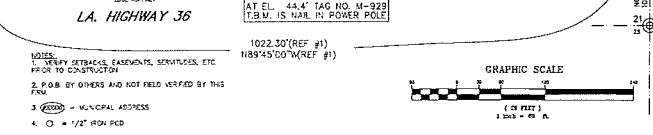
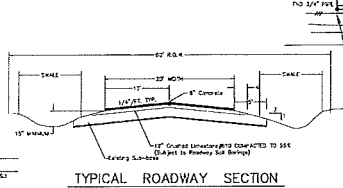
