ORDINANCE ESTABLISHING A NO PARKING ZONE ON TITUS
TAYLOR RD (2-P-38) (WARD 2, DISTRICT 6)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and welfare of citizens of the Parish; and

WHEREAS it is necessary to impose a no parking zone to prohibit parking of vehicles within the rights of way of Titus Taylor Road (2-P-38) for the entire length of said road (approximately 658 feet), to protect the health safety and well being of motorists traversing said roadway.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it hereby establishes a "No Parking" zone on Titus Taylor Road (2-P-38) Ward 2, District 8

BE IT FURTHER ORDAINED. that the Department of Public Works is authorized and directed to place signs effectuating said No Parking zone on Titus Taylor Road (2-P-38)

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
