425-81	Supportive Housing FY 17	US Department of Housing & Urban Development: Grant award received for rental and utility assistance, along with supportive services to low income individuals.
440-04	Airport - Gen. Aviation Maintenance Program	State of LA, DOTD - Grant award received for reimbursement of grass cutting and maintenance at Greater St. Tammany Airport in Abita.
450-09	DOTD-Rural Transportation	State of LA, DOTD: Grant award received for transit operations in the amount of \$210,000. Grant has a 50% match which is to be provided by COAST millage for elderly transit, STARC, and cash fares.
