AN ORDINANCE AMENDING THE ST. TAMMANY PARISH CODE OF ORDINANCES PART 1, CHAPTER 2 ADMINISTRATION, ARTICLE XVII(3)II, SECTION 2-683(5) RELATIVE TO BUILDING PERMIT FEES BY ADDING A NEW FEE RELATIVE TO HANDICAP RAMPS.

WHEREAS, a construction of handicap ramps are considered an addition to single family residences under the existing fee structure; and

WHEREAS, residential additions are charged \$ 180.00 plus \$ 0.10 per square foot; and

WHEREAS, it is the desire of the Parish of St. Tammany to provide for a specific fee for the constructions of handicap ramps when not part of a larger scale new construction, addition or renovation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that it amends St. Tammany Parish Ordinance Code of Ordinances Part 1, Chapter 2 Administration, Article XVII(3)II, Section 2-683(5) relative to Building Permit Fees by adding a new:

k. Handicap ramps when not associated with another building permit \$ 60.00.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

ADMINISTRATIVE NOTE

Under the present fee structure a 136.5 square foot handicap ramp would be considered an addition and subject to a \$245.02 permit fee. The proposed \$60.00 fee will essentially cover the cost of the plan review for handicap ramps when the ramp is not part of a larger project (i.e. residential or commercial new construction).
