ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO REMOVE THE NORTHERN PORTION OF BOBBY JONES BLVD (10-F-19) FROM INVENTORY AND CLOSE TO THRU TRAFFIC. (WARD 6, DISTRICT 6)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the Road and Drainage Inventories based upon the recommendations of the Department of Engineering, Director of Public Works, 911 facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage System Inventory is amended as follows: 1. Remove the northern portion of Bobby Jone Blvd (10-F-19), approximately 2,435, feet between Hillcrest Blvd and Iron Street and to close to thru traffic. (ward 6, District 6)

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
