### **Administrative Comments**

The Resolution authorizes the Parish President (Patricia P. Brister) to execute and file the Rural Public Transit Program (FTA Section 5311) application, assurances, or any other additional information as the Louisiana Department of Transportation and Development (LADOTD) may require in regards to the Rural Public Transit Program. The 5311 application is due February 1, 2017 for the State Fiscal Year July 1, 2017- June 30, 2018

The STAR Transit program is funded by FTA and disbursed through Louisiana Department of Transportation and Development. These funds are used to offset the cost of operating curb to curb transportation to the rural population of St. Tammany Parish for employment, medical, entertainment, shopping etc. The service operates Monday – Friday 6AM - 6PM. This year the Parish will have to provide a 50% match for this program which will be obtained through contributions from municipalities, COAST and STARC.
