BRISTER) TO ENTER INTO AGREEMENT WITH THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO PROVIDE PROGRAMING AND ASSISTANCE THROUGH THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FOR FISCAL YEAR 2017 WITH THE DIRECTOR OF GRANTS (JEANNE BETBEZE), GRANTS PROJECT MANAGER (ANGIE TRAILL) AND HHS DIRECTOR (ALLYSON VILLARS) TO AUTHORIZE MONTHLY REPORTS FOR REIMBURSEMENT AND BUDGET REVISIONS
