A RESOLUTION TO SUBMIT A NEW APPLICATION FOR THE USE OF THE PARISH'S KATRINA/RITA COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING TO IMPLEMENT A PROJECT FOR GRANTOR ELIGIBLE ACTIVITIES.

WHEREAS, St. Tammany Parish Government shall use 659,256.19 from Katrina/Rita Long Term Community Recovery program funds to complete sewer & water improvements in the Ben Thomas/Alton Areas of Slidell, LA. The total Katrina/Rita funds to be utilized are remaining from the following, completed projects: Reno Hills Area Sewer System Project in the amount of 581,982.13, Lapin Street Drainage Improvements in the amount of 72,019.37, and Sharp Road & Century Oaks Drainage Improvements in the amount of 5,254.69.

WHEREAS, St. Tammany Parish Government shall also use 669,980.40 from Katrina/Rita Program Income to complete sewer & water improvements in the Ben Thomas/Alton Areas of Slidell, LA. The total Katrina/Rita Program Income to be utilized is remaining from the following projects: Green Property in the amount of 289,730.00 and Unobligated funds in the amount of 380,250.40.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES to approve the new project application(s) and designate the Parish President as authorized signature for the Katrina/Rita application(s) along with all grant documents.
