TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09, is authorized to execute a Cooperative Endeavor Agreement with the St. Tammany Justices of the Peace and/or St. Tammany Constables regarding the enforcement of Parish's property standards and/or nuisance violations and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.
