AN ORDINANCE TO ESTABLISH NO PARKING SIGNS ON THE ENTIRE WIDTH ROW ALONG THE ST. LUKE THE EVANGELIST CHURCH PROPERTY ALONG CROSS GATES BLVD. WARD 8, DISTRICT 9

WHEREAS, the Department of Public Works finds it necessary to impose no parking signs to prohibit the parking of vehicles within the rights of way along St. Luke the Evangelist Church property along Cross Gates Blvd from the AT&T substation to the 1st concrete driveway to the church. Trucks are parking on the grassy area of the ROW and are breaking the water main that then requires a Boil Water Advisory to be issued to residents. Ward 8, District 9

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that it hereby establishes a "No Parking" signs on Cross Gates Blvd. Ward 8, District 9

BE IT FURTHER ORDAINED, the Department of Public Works is authorized and directed to place signs effectuating said No Parking Signs along Cross Gates Blvd from the AT&T substation to the 1st concrete driveway to church. Ward8, District9

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
