RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER, SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE REGIONAL PLANNING COMMISSION FOR A PEDESTRIAN SAFETY FEASIBILITY STUDY ALONG US HIGHWAY 190 (SOUTH MILITARY ROAD) FROM TURTLE CREEK BLVD TO US 190 (EAST GAUSE BOULEVARD) (WARD 8, DISTRICTS 8, 9 AND 13)

WHEREAS, St. Tammany Parish Government and the Regional Planning Commission desire to develop a pedestrian safety feasibility study for US Highway 190 (South Military Road) and adjacent roadway network from Turtle Creek Boulevard to US Highway 190 (East Gause Boulevard) in Slidell; and

WHEREAS, the State of Louisiana, Department of Transportation and Development has provided funding for the study, subject to a local match; and

WHEREAS, the Parish desires to provide funding for the local match in order to facilitate the Regional Planning Commission's procurement of the study.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter, Sections 1-04, 1-06, 3-01 and 3-09, is authorized to execute a Cooperative Endeavor Agreement with the Regional Planning Commission, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the pedestrian safety feasibility study for US Highway 190 (South Military Road) and adjacent roadway network from Turtle Creek Boulevard to US Highway 190 (East Gause Boulevard) and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

## **Resolution Administrative Comment**

RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE REGIONAL PLANNING COMMISSION FOR A PEDESTRIAN SAFETY FEASIBILITY STUDY ALONG US HIGHWAY 190 (SOUTH MILITARY ROAD) FROM TURTLE CREEK BLVD TO US 190 (EAST GAUSE BOULEVARD) (WARD 8, DISTRICTS 89 AND 13)

Parish seeks to enter into a Cooperative Endeavor Agreement with the Regional Planning Commission for a pedestrian safety feasibility study. The general boundaries are U.S. 190 ("South Military Road") between Turtle Creek Blvd. and US Highway 190 ("South Military Road"). RPC will procure and administer a contract with a vendor. Parish will provide the local match for DOTD funds otherwise provided to RPC.

Based on an estimated project cost of \$40,000.00, Parish's local match is 20% or approximately \$8,000.00.
