RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER, SECTIONS 1-04, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH STARC OF LOUISIANA, INC. FOR JANITORIAL SERVICES.

WHEREAS, Parish owns and operates multiple facilities that are in need of cleaning and janitorial services; and

WHEREAS, STARC of Louisiana, Inc. ("STARC") desires to provide janitorial services to certain Parish facilities.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter, Sections 1-04, 3-01 and 3-09, is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all requirements of Louisiana law and jurisprudence, with the STARC of Louisiana, Inc. for janitorial services to Parish facilities and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions authorized herein.
