RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01, AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, TO SIGN AND/OR EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE ST. TAMMANY PARISH DRAINAGE DISTRICT NO. 2, FOR THE OPERATION OF PUMPS IN COUNCIL DISTRICT 13. WARD 9, DISTRICT 13.

WHEREAS, the St. Tammany Parish Drainage District No. 2 operates pump(s) within its boundaries which benefit the residents of St. Tammany Parish Drainage District No. 2 and Council District 13; and

WHEREAS, St. Tammany Parish Drainage District No. 2 has previously entered into a Cooperative Endeavor Agreement with St. Tammany Parish Government for the repair and/or replacement of hurricane damaged pumps; and

WHEREAS, while the repair and replacement of said hurricane damaged pumps takes place, St. Tammany Parish Drainage District No. 2 is renting a pump for the benefit of the residents of St. Tammany Parish Drainage District No. 2 which also benefits residents throughout Council District 13; and

WHEREAS, said pump rental is placing a strain on the limited budget of St. Tammany Parish Drainage District No. 2, and, in order to protect the residents of Council District 13, the Councilmember of said district desires to utilize certain St. Tammany Parish Sales Tax District No. 3 funds in the District 13 Capital Budget to maintain the rental pump while hurricane damaged pumps are being repaired and/or replaced; and

WHEREAS, the above use is an appropriate use of St. Tammany Parish Sales Tax District No. 3 funds, as said expenditures will benefit the residents of St. Tammany Parish Sales Tax District No. 3 and Council District 13.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, Pursuant to Home Rule Charter, Sections 1-04, 3-01, and 3-09, is hereby authorized to sign and/or execute a Cooperative Endeavor Agreement with the St. Tammany Parish Drainage District No. 2, which meets or exceeds all requirements of Louisiana law and jurisprudence regarding the maintenance and operation of a rented pump, and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions authorized herein.
